TERMS & CONDITIONS OF THE TENDER DOCUMENT

1. ELIGIBILITY:

i. The bidder must have at least 5 years of experience in the field of supply, installation and support of Data Centre and critical IT infrastructure. They should carry necessary experience in maintenance of IT infrastructure which includes Servers /Storage / Network Infrastructure / Data bases / PCs

ii. The bidder should have proven ability in maintaining IT support personnel to support critical IT infrastructure.

2. FINANCIAL CAPABILITY:

The bidder should be a Private / Public limited company and Turn over should be minimum 5 crores for either FY 2021-22 or average of three financial years FY 2019-20, 2020-21 and 2021-22. Documents evidencing the same are to be submitted along with the bid.

3. EXPERIENCE:

The bidder should have successfully executed at least one contract of similar nature (Managing the IT infrastructure which includes DC, Servers and PCs, Network Infrastructure, Data bases) during the last 2 years.

4. PERIOD OF THE CONTRACT:

The services are expected to be in place commencing from 1st Feb 2023. The period of the contact is for one year which is extendable, at the sole discretion of the Bank, at the same terms, for a period of five years on yearly basis.

5. DOCUMENTS TO BE SUBMITTED:

- 1) Application for the Tender has to be submitted in two separate sealed covers as under:
- i. First sealed cover should contain documentary evidence to support eligibility criteria.
- ii. Second sealed cover should contain the commercials of the BID. Bids submitted that are not in conformity with these conditions will be out rightly rejected.

- iv. Managed Services to be available on 24x7x365 basis for IT Infrastructure of the Bank which includes Servers, Storage, Network infrastructure, PCs and data bases at our Data Center as well as at our branches.
- v. Managing Team at Head office, to maintain the IT Service Desk, with sufficient number of support staff, at least 6 resources and a supervisor, as single point of contact, with proven capabilities and expertise to address the above activities and provide effective support and time bound solution. Support personnel should be in a position to visit branches and address the issues.
