The scope of work and other terms & conditions of the contract are as under:

I) Scope of work:

- All types of general electrical breakdowns, repairs and maintenance (other than IT) to be attended on call, excluding transformer and high-tension line works.
- Maintenance Inverter & Air Conditioning Units Power Lines, MCB distribution Boards lines.
- Earthing & Power Load Verification and issuing test certificate.
- Light Fittings and Name Board Timer related to general electrical works.
- Main Supply (Near Meter Boards etc).
- Checking of Fire, Burglary Alarm & Smoke Detector Systems pertaining to general electrical wiring of respective gadgets and Telephone cabling works etc.
- Carrying out of preventive maintenance service monthly once at all the sites, in addition to break down calls.
- Ensure for proper functioning of all electrical connections at Head Office, Banjara Hills and make certain for arranging / exclusive deployment of an electrician, at all times at Head Office, Banjara Hills & also during break down calls for maintenance of general electrical works.
- Any other general electrical maintenance works (other than IT) entrusted by the authorities at 35 Local Branches & Head Office, Banjara Hills, from time to time.
- **Payment Terms**: Payment shall be made at Head Office, Banjara Hills at the end of each quarter, on submission of reports confirming satisfactory service from all centers noted above. In the absence of receipt of service report from any branch, proportionate payment will be withheld.
- TDS as applicable will be deducted.

II) Terms & Conditions:

- "A" Class Electrical Contractors / "A" Grade Licensed Electrical Contractors, having required manpower are only required to collect Tender Forms.
- Tenderer is advised to use Tender Form supplied by the Bank only. Tenderer is requested not to make any alterations in the Tender Form.
- Tenders found not as per the Bank's specifications will not be entertained.
- In case the Tenderer is a Company / Firm / or any other legal entity, the proof of Incorporation / Resolution authorising to sign tender document is required to be produced.
- The Tenderer's signature and seal should be affixed on each sheet of the tender form and there should not be any overwriting.
- Tenderer / Service provider with a minimum of 5 years experience in Maintenance of Electrical Gadgets is only required to apply for the contract. Tender will not be entertained if the service provider is not having the required experience. Experience Certificate from the existing clients / customers of tenderer shall be produced with satisfactory report to the Bank.
- Tenderer / Service provider to have sufficient number of qualified / skilled electricians for maintenance of Electrical Gadgets installed at Head Office, Banjara Hills and 35 Branches.
- The rate / amount quoted in the tender shall be inclusive of all.
- The rate / amount quoted in the tender for three years stands binding till completion of contract. Meanwhile, request to increase in the rate / amount by the tenderer will not be considered, after submission of tender / finalization of contract.
- Upon successful bidding, the successful bidder shall execute a MOU (Maintenance Contract) of Electrical & Internal Telephone Cabling Woks of Head Office, Banjara Hills and 35 Local Branches with the Bank, adhering to the terms & conditions of the contract.
- Copy of PAN / GST registration of the Company / Firm / Individual (s) to be submitted by the tenderer.
- Charges quoted shall be inclusive of Labour charges, GST etc.
- Annual review of performance of the contractor / service provider shall be done by the Bank for renewal of Contract, on year on year basis. In case the performance is not satisfactory, renewal of Contract will not be done with the existing Contractor. Bank reserves the right to award to another firm, who is competent to carry out the maintenance contract.

- TDS as applicable will be deducted from the quarterly payments.
- The profile of the Tenderer / Firm should be furnished in the enclosed form duly mentioning PAN / GST Number.
- There is no permission to sub-contract the works under the present tender.
- The tenderer shall ensure that in the event of work allotment under the tender, they shall comply with all statutory provisions including Labour Laws as applicable from time to time.
- Work shall be allotted on successful tenderer in the name of the applicant only.
- Duly filled in tender form along with prescribed EMD should be submitted kept in a sealed cover / envelope on or before 24.09.2024 by 6:00 p.m. to the Asst. General Manager (Admn. & Ops), Head Office, Road No.12, Banjara Hills, Hyderabad.
- Bank reserves the right to accept or reject any or all tenders without assigning any reason whatsoever.
- Bank reserves the right to negotiate the total charges / amount quoted in the tender submitted with any / all the tenderers and finalizes the Contractor for carrying out Maintenance Contract.
- The Bank does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all of the tenders received without assigning any reason thereof. Further, the Bank reserves the right to award the Contract to any other / different tenderer, who is competent to carry out the maintenance, instead of the lowest tenderer.
- In case of any lapses in discharging of services by the service provider / their employees, the service provider will be barred for participation in future bids and shall be blacklisted forever.
- Mere confirmation of tender does not confirm any contractual rights upon tenderer / service provider.

EMD

- a) EMD of Rs.25,000/- should be submitted along with the tender form, by way of Banker's Cheque / Demand Draft favouring Andhra Pradesh Mahesh Co-operative Urban Bank Ltd., payable at Hyderabad.
- b) Tender form without sufficient EMD or no EMD will be rejected outright.
- c) There is no exemption from payment of EMD even for SSI or whatsoever category. All the tenderers should invariably submit prescribed EMD.
- d) In case the successful tenderer / service provider backs out or does not carry out the Annual Maintenance Contract of Electrical Works properly, the entire EMD kept with the Bank will be be forfeited.
